Local businesses burglarized

There have been a string of burglaries in Wasco over the last several months, with some businesses suffering multiple thefts. Thousands of dollars in stolen merchandise have been lost.

True Value Hardware is one of those

WASCO

businesses.

On April 1, the store was broken into for the seventh time in the last year and a half. This time around, chainsaws, weed eaters and power tools valued at \$3,000 were stolen.

They have lost almost \$40,000 in merchandise in total.

The Kern County Sheriff's Office made an arrest related to the robbery, but the suspect was later released.

"It is upsetting, and we feel hopeless. Law enforcement seems to have their hands tied behind their backs. They say that there

is not much they can do because of legislation that permits criminals to be released back into society," said True Value store manager Luis Fernandez.

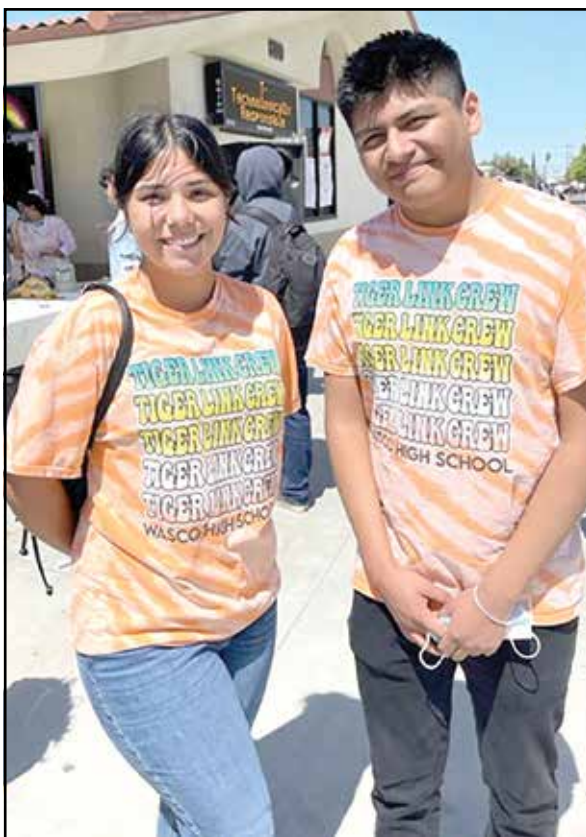
In the past, criminals have stolen merchandise in plain view.

"One time, the criminal pulled a knife

Generals' home renovation gains ground

The Shafter High Generals will have a renovated home come this fall, with a total rebuild progressing despite a number of challenges. The new stadium project has been underway for over a year, but delays have caused the project to push back its completion dates.

According to Principal Russell Shipley, one reason for the delays is the attention to detail that the leaders of this project have. With demolition and new construction underway, they saw modifications and improvements to the already substantial design.

For one thing, they saw the need to reposition the current location of the pole vault and runway area to a more feasible location. While this sounds simple, it turned into a large redesign, which included adding a full synthetic surface to the north side of the field. This area will be fully

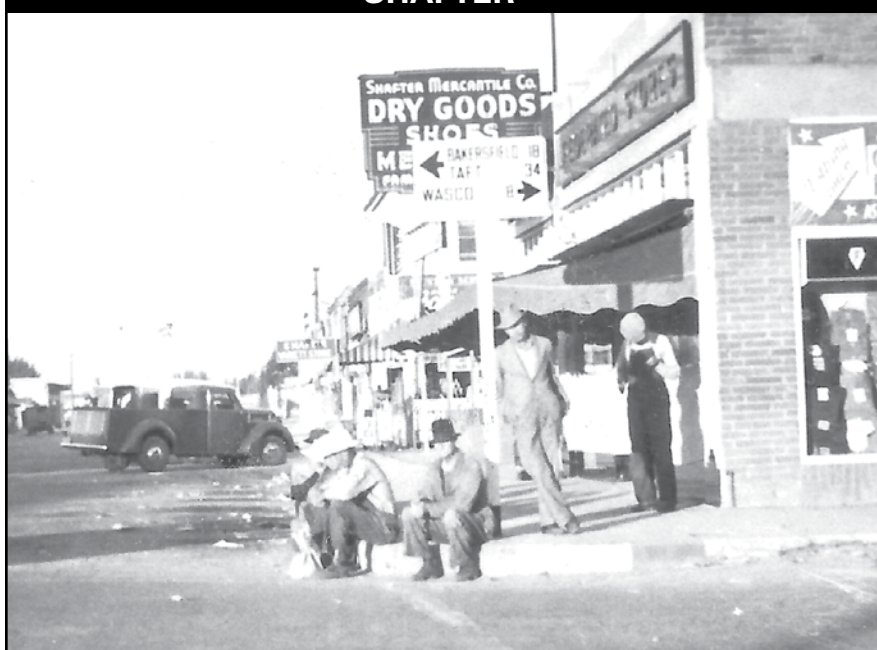

As a result of frequent moves during the school year, most migrant students demonstrate education needs in reading, math and health services.

Identifying migrant students is a goal in order to provide them with education instruction that promotes optimal physical, intellectual and social development.

The program serves migrant students in countless ways. Over the years, they have helped hundreds of students prepare for the next chapter in their lives post-high school graduation.

There are many services we provide to help migrant students realize their full potential, said Okolonwamu.

The main focus is on academics, and we offer migrant students tutoring after school. We also introduce them to Northern and Southern California colleges."

As part of the program, students participate in special workshops and retreats at different universities. This year students will attend a residential engineering program hosted by Cal Poly San Luis Obispo. Others will take part in a two-week STEM

course at UC Santa Barbara, with some attending a leadership program there.

These retreats would be out of reach financially for migrant families. We fund what would cost parents thousands of dollars through our program," said Okolonwamu.

It gives many opportunities to those from low-income families," student Gael Lopez said. "Through the program, I have

learned that I am not alone. I always have someone I can turn to for help.>"

What I love most are the teachers. They are very kind to the students and each other."

This year Lopez will be the first student from Wasco Independence High School to participate in the program's Washington, D.C., trip.

Every year we take 12 students to Washington, D.C., to understand more about the legislative process. We visit local monuments, including a tour of the White House, Okolonwamu said.

This will be an important experience because I have never traveled outside of California, except for Mexico, Lopez said.

It will be a chance to explore more about the rich history of the United States. It will also help me in the future because it will broaden my horizons and give me a more worldly perspective on life."

Wasco Independence High School counselor Vianney Gonzalez is a program graduate.

As a high school student, it prepared me by showing me options to pursue higher

education, said Gonzalez.

Not only was it an enrichment program, but it also paid for my college applications, so my parents wouldn't have to pay out of pocket. That took the burden off of my family."

The program allows students to communicate and see the success of other students and adults from migrant communities.

This serves as inspiration and motivation, Okolonwamu said.

A unique component is helping first-generation college students by guiding them along the college path and all of the different elements needed to enroll and later graduate.

As first-generation college students, the program holds our hands along the journey. I have three other sisters that went through the program, and all of us earned bachelors and masters degrees, said Gonzalez.

That a migrant family achieved this is remarkable. I credit this accomplishment to the program, and I will forever be grateful.

finished with a synthetic terracotta surface and configuration for the high jump and pole vault area.

This added additional landscaping and irrigation changes to the south side of the stadium. When completed, the stadium will have a track surface and sufficient lanes to host major competitions, including regional and state competitions.

In addition, updates and changes were added to the second concession stand lo-

cated on the south east side of the stadium, near the ticket booth.

Many of the other delays can be attributed to detail and making sure the stadium and overall financial investment were meeting all foreseen needs. "We wanted to make sure it wasn't 'good enough,' but perfect and great for many, many generations to come," Shipley said.

Shipley said that the goal is to have the main field ready with sod and irrigation so the class of 2022 can graduate in the new

stadium. There is a contingency plan if the main field is not ready in time, though.

The stadium will not be completely done at that time and much of the final synthetic surface, track and final touches will be completed in the summer. Shipley said that there are many variables that may control or delay the completion, including supply, demand, transportation of goods, etc.

In the end, Shipley said that the stadium will be one of the nicest and most state-

of-the-art stadiums throughout the county.

"It will be a shining star for our Generals and our community. Even during construction we have had many visitors coming out to see the progress of the stadium because they heard rumors about how 'fancy' it was."

After playing a season as nomads, roaming from stadium to stadium for their home games, it will be a welcome sight to see Shafter's newest jewel full of fans on a Friday night.

Hosanna, 'Save Us Now!'

When the people heard He was coming, they lined the streets hoping to see Him. They sacrificed their best coats and stripped nearby trees to create a makeshift red carpet to honor him. They shouted "Hosanna" over and over when He came into sight. (See Mark 11:1-10)

The strange thing is that many from this same crowd were shouting again a few days later, but this time, they were calling for His execution. "Crucify Him! Crucify Him!" (See Mark 15:6-15)

Have you ever wondered about these fair-weather friends or fickle fans of Jesus? What could make them so enthusiastic one moment and so ready to condemn the next?

When they cried, "Hosanna," they weren't just saying "hurray." The Aramaic root word for "Hosanna" actually means "Save me now!" Even if they were not fully aware of it, they were crying out for help.

Like us, the people of Jerusalem were living through times that were difficult economically, politically and personally. Life was hard, and they were desperate for solutions and ready to listen to anyone who could give them new hope.

Some had heard that this Jesus could feed thousands with a child's lunch, heal contagious and incurable diseases like leprosy and, rumors claimed, just days ago, He had even brought someone back to life who had been dead and buried for days. Of course, what they were really hoping, is that He would use all that power to force out their oppressive rulers and start a new golden age, the messianic kingdom they all dreamed about.

So, they came to check Him out. And they shouted, "Save me now!" But what they meant was, "Save us from our unjust government!" "Rescue us from our money troubles!" "Fix all our problems!" And when Jesus didn't immediately do all that and He wouldn't even fight for Himself before Pilate, it was all too easy for them to just listen to the next influencer whispering in their ears and join the crowd shouting for Him to die.

What they didn't understand is that He did come to save them. Like us, they thought that if He could save them from their circumstances, everything would be fine. We sometimes imagine that if we could just get rid of the politicians we don't



agree with or if we just had enough money or if something in our situation (our health, our home, our job, our family) changed, we could finally be happy.

Truth is, even if all those fantasies came true at once, we'd still find ourselves longing for something more. We don't need saving from our circumstances; we need saving from ourselves.

Jesus came to pay the price on the cross for our sin and selfishness, so we could live in continuous relationship with our loving Father God, the only one who can fill us with peace and make us feel whole, regardless of our circumstances. We just need to recognize that we need saving and that only He can save us.

We need to stop listening to every new voice (or advertisement) that claims to have the answers to make us happy, better, healthy, wealthy, wise... etc. It's time to say, "Hosanna, Jesus, save us now!" and mean it. Not like the people who shouted in the streets and then turned their backs on Jesus days later, but time to make a real commitment to give Jesus your whole life and wait patiently to see what He can do with it.

This resurrection Sunday is the perfect time to cry out "Hosanna, save us now" alongside your neighbors! If you're an early riser, join in the sunrise service at Mannel Park at 6:30 am. If not, head to your local church and join in the festivities. Don't worry about having the right clothes or even if you haven't been there in a while. They'll be glad to see you! If you don't have a local church, there are so many here, including ours, that would welcome you with open arms and help you keep that commitment you've made to Jesus.

on us. I tell my employees it's just not worth trying to stop them because we could be killed," said Fernandez.

On April 6, Vicky's New Image Salon,

located downtown, was burglarized. Their front door was broken, and their windows were smashed; that is how the criminal, or quite possibly criminals, entered the store.

"We suffered an expensive loss," owner Juana Pelayo said. "They took everything. All of our hair products, blow dryers, curling irons, flat irons and our brand new television were taken. They even stole the candy and toys I had for my younger clients."

The sheriff's deputy arrived and took a report.

"Even so, I am not confident that the crimes will be resolved. I am concerned that even if they catch the suspect, the suspect will be released, and no justice will be served as it has happened in the past," Pelayo said.

For the most part, victims are not being reimbursed for their losses.

"Over the years, I have been robbed five times. In the past, our insurance company has never covered any of the damages or stolen merchandise. It is hard enough to run a business in this economy, and these crimes make it more challenging to survive and make a profit."

Many are worried about being broken into again.

"We need help. I don't feel safe any more, and worry about my business's future knowing that I could be burglarized again," said Pelayo. "It is too easy for the criminals because they could be let go if they are caught."

In December, Wasco's Barber Lounge, also located downtown, was burglarized.

"There was over \$4,000 in stolen property and damage to broken windows and doors," said owner Mario Martinez.

Victims are pleading for more patrolling.

"We need more law enforcement presence. We see them around the city, but we need more patrolling downtown," said Martinez.

"It would be nice for the city to install cameras and more patrolling. Thieves would think twice about breaking in."

Victims are frustrated that criminals are released just hours after being apprehended.

"I believe the laws should be changed. It is frustrating that when thieves are caught

committing the same crimes repeatedly, there should be a law that forces criminals to remain in custody," said Fernandez.
