

## Museum curator talks city's namesake



Using photos, excerpts from written material and a postcard that he owns of Gen. William Shafter's birthplace, Shafter Depot Museum curator Stan Wilson brought the city's namesake to life at the Shafter Learn-

ing Center

The center began a history series last Thursday night with Wilson's lecture on the life and times on Gen. Shafter. "Shafter was a school teacher when he

joined the 7th Michigan Volunteers during the Civil War. He was

given the rank of lieutenant, and as an officer so distinguished himself that he was promoted to the rank of Major General of Volunteers by the end of the war." Wilson went on to say

that one of Shafter's assignments was to recruit and train Black troops, who he molded into a fine infantry force. After the war, he was mustered out of the Army, but he applied to remain and was accepted. He was granted the rank of lieutenant colonel and given command of the Black infantry, with the assignment to patrol West Texas along the Rio Grande to protect American settlements from attacks from bandits and Indi-He led a relentless

march across the Llano Estacado to the Pecos

River, thus earning him the nickname "Pecos Bill."


During his long military career he also served as head of Army recruitment and on a Weapons Procurement Board in South Dakota and in Arizona, and was eventually given command of the Department of California, based in San Francisco, by which time he had been promoted to major gen-He was selected to lead a "grossly un-

prepared" army against Spain in the Spanish American War in 1898. Yet within a month, recruits were trained and supplies were loaded on ships for Cuba. When they arrived, they were met by a lot of rain, impassable roads, disease and poor logistics. Teddy Roosevelt and the Rough Riders were under his command when they took San Juan Hill. That was the major skirmish

of the war. Shafter proceeded with negotiations with the Spanish and demanded surrender. He outfoxed them, and they surrendered. It was a major feat, as the Spanish army outnumbered Shafter's men 24,000 to 17,000. Shafter became an instant hero in America. The short war saved many lives on both sides. After his return he was a much-sought

speaker for many celebration events, and his picture appeared in media and advertising. And so, in 1898, when the SF&SJ Valley Railroad was completed to Bakersfield, Henry Jastro of the Kern County Land Co. suggested his name be used for the station north of Bakersfield. Shafter was a very colorful character,

and his personality was not unlike the parts that John Wayne played in many of his

when we come to Wasco, residents show up to support the mission because they know how important it is," said Houchin Community Blood Bank Chief Operating Officer Martin Alonzo. Each blood donation can help save or

improve the lives of at least three people.

Every two seconds, someone in the U.S. needs blood. In Wasco, current blood inventories are critically low. "It is more important now than ever to

have our community members come out to support the blood donation process. We need their help to ensure that we have sufficient blood on the shelves to respond to those tragic emergencies that come up or are unexpected," explained Alonzo. Blood donors help patients of all ages —

accidents and burn victims, heart surgery and organ transplant patients and those battling cancer. Anyone can donate as long as they are

18 years and older, weigh over 110 pounds

and pass a quick health screening. There is no cut-off age and a person can donate every eight weeks.

Donating is easy and the whole process takes about 45 minutes, most of that time is spent conducting a minor health check. The screening is beneficial because it provides the donor with their cholesterol level, blood pressure and blood type.

Assemblymember Rudy Salas introduced a bill to give California beneficiaries of the State Supplementary Program for the Aged, Blind, and Disabled an increase of \$600 in benefit payments in years that the state has a budget surplus. "I want the senior, blind and disabled

to know we are out there fighting for them. We hear their pleas, and that they need help. When California is doing so well, there is no reason that we can't do more. AB 1941 is a measure that will help all of them in a real way by giving them a \$600 increase in their social security payment," stated Salas.

Over the last 10 years, California has had a budget surplus, and this year it is projected that there will be a historic budget surplus of \$45.7 billion. "From 2021 data, 1.2 million people would benefit from the passage of this bill," Salas said.

"If 1941 does not get implemented, the senior, blind and disabled are going to continue to struggle. We should be doing everything in our power to help these groups that are the most vulnerable and the most in need," Salas added.

Covid-19 has disproportionately affected at-risk members of society, Salas said. Over 15 million Americans age 65 and older are now economically insecure, living at or below 200% of the federal poverty level.

Record high inflation rates have also made it more difficult to survive.

"Often, it means the difference between choosing to put food on the table or having access to life-saving medication," Salas said. The cost-of-living adjustment has only increased social security payments by 5.9%, even though inflation hit a 40-year high of 7.5% in 2021.

If the governor signs the bill, it will take effect on Jan. 1, 2023.

"Although there could be an urgency clause added, and the money could be distributed sooner, but we would have to get him on board," he said.

Salas asks the community to support this bill. "We need everyone, not just the seniors, blind and disabled, to say this is something we support, that it is something that is needed, and that it is something that makes sense," Salas urged.

"Letters of support from individuals, companies, and anybody who worries about their older parents and family are needed. We know that this is something that definitely will provide them with valuable and, in some cases, life-saving financial assistance," stated Salas. Letters can be mailed to the State Capi-



Among the diners was a big party with a mix of Garcias and Abernathys, who took advantage of the special. There



ployees and insufficient revenue, they could not secure any bank loans. Also, they did not qualify for government assistance.

"It was a difficult decision. We could not stay afloat," Tapia said. "The best part of our business undoubtedly are our customers. They are great people, and it was an honor to serve them with their dry cleaning needs. We are going to miss our clients very much."

Some of their biggest clients included the California Highway Patrol and the Kern County Sheriff's Office that brought in their uniforms, the City of Shafter Police Department where they cleaned all of their blankets for the jail, and West Side Family Fellowship, where they took care of

their linen.

Their closure will be a loss for local schools.

"We helped the Wasco High School cheerleaders buy their uniforms, sponsored football games, and even supported a local youth to attend an out-of-state wrestling competition," said Tapia.

In line with their charitable work, they will donate any unpicked-up clothing to the local Goodwill.

With their closing, there will no longer be a dry cleaning business for the residents of Wasco.

"Hopefully, the economy improves, and there will be another dry cleaning business that opens. It is going to be hard for those clients that relied on us to take care of their laundry needs,"



Feb. 15. He is being represented by attorney Kyle Humphrey. Humphrey has been in private practice for over 10 years after serving several years in the Prosecutor's



Kern County has many jewels, places and things for which we can be proud. Two of them are the Buena Vista Aquatic Recreation Area (BVARA) and Kern River Parkway Bike Trail. Back in 2013, when I was a new Supervisor, BVARA was in District 4 as was much of the bike trail. It seemed appropriate to try to connect them and to enhance both assets. So I discussed this with the Public Works Department, they started the conversation with the other stakeholders, most notably the Kern Council of Governments (KernCog), and just like that, it

was done. Ok, actually it took 9 years but I'm so happy to announce that this Thursday, Feb. 17 at 10 a.m., we will finally be celebrating the opening with a ribbon-cutting ceremony at the BVARA Entrance. The public is invited, and you might want to bring your bike, as there will be an inaugural bike ride

It took a while, and it may not seem like much, but these 6.3 miles of new bike trail took a tremendous amount of planning and

involved multi-agency cooperation. The

path required that we cross under an interstate highway and bypass a racetrack, faced challenging environmental and rightof-way hurdles, and it included stake holders like the Kern Wheelmen and Bike Bakersfield. It took Kern County ingenuity to figure out how to fund this effort primarily using Caltrans funding obtained through KernCog and not our local general fund tax dollars. And it took patience, as COVID and labor shortages

lengthened the time it took to build this

trail. If you've been to the bike path, you know that this trail is used by so many families and athletes, whether they're walking, jogging, riding, skating or even pushing a stroller. Events include moonlight bike

can ride there too. Programs like this are encouraged by KernCog and the elected officials that make up this body and show how we as a County and all our local jurisdictions can work together for all. Bike trails help to reduce traffic congestion, clean

## God's presence with Joseph

#### **PASTOR RUBEN ZARTMAN**

Ebenezer Reformed Church, Shafter

The story of the Old Testament patriarch Joseph is one of the most dramatic in the Bible. With a couple of interruptions this story runs in *Genesis* from chapter 37 to the end of the book (chapter 50).

During that time, Joseph's brothers first planned to kill him and then decided to sell him into slavery instead. Once in Egypt he was imprisoned as a result of a false accusation. A prisoner whom he helps forgets all about him for a long time. Joseph's story for a very long time is one of undeserved suffering.

However, that isn't the whole story. Ultimately, Joseph wound up being in a posi-

tion to deliver the very family who had mistreated him from a disastrous famine. He was taken out of prison and given a position of great authority and responsibility in administering Egypt. Even before that happens, though, there is a strange expression used about him: "The Lord was with Joseph, and he was a successful man ... the Lord was with him; and whatever he did, the Lord made it prosper" (Genesis

39:2,23 NKJV). That's a strange expression because of

the circumstances. Joseph lost his fam-



a prisoner. A false accusation against him and his undeserved imprisonment took place in between the two verses that say that the Lord was with him. Given that things only seem to be getting worse, how can the Bible say he was successful because God was with him? This choice of language sug-

ily, and wound up in Egypt,

first as a slave, and then as

gests three important lessons:

God's presence does not mean bad things don't happen. Prosperity and adversity are not, by themselves, proof of God's favor or displeasure.

Success and prosperity by God's blessing are connected to how we respond to adversity, not to our freedom from trouble. Even when things went badly, Joseph continued to carry out his responsibilities. That was the real proof that God was with him.

Trials and problems do not mean God has abandoned us. Our sufferings and tribulations don't alienate God from us.

If your life story were being written, would you say over all the rough patches that you prospered because God was with


