## Shafter gets \$2.5M grant for projects

The San Joaquin Valley Air Pollution Control District has approved a \$2.5 million grant for improvements in Shafter, focused on a cleaner air environment, as well as improvements in the safety of the residents.

Included in the plans for the grant money are projects that will create bike lanes and improve the safety of the shoulders along Highway 43 in the North Shafter area, as well as the area known as the La Colonia in Shafter, resulting in a safer environment for residents and its children.

Although we are very thankful for the reduction in PM2.5 that this project will have in our community, the safety that this can bring to our community will be valued so much now and in the future," said Lynnda Martin, Shafter CSC member.

The city has already approved projects that will give the residents a park in the North Shafter encouraging a safe environ-

ment for the children to play, as well as an improvement in the air quality for the area.

Mayor Cathy Prout served on the AB617 Steering Committee that was formed to help reduce emissions in the air in the San Joaquin Valley, specifically the Shafter area. The committee created a master plan that will help reduce emissions in the area and will also give the businesses a choice for a greener way to operate, including swapping old gas-powered machinery with new electric equipment that would reduce emissions in the air.

"This grant will go a long way in improving the quality of life in Shafter, including the air quality, as well as the safety of its residents," Prout said.

Also as part of the grant, the existing public transit vehicles will be replaced with electric or hybrid vehicles at a cost of approximately \$400,000.

## Mental health of teens suffering due to the pandemic

Youth experienced a unique set of challenges during the Covid pandemic.

As a result, there has been a rise in mental health issues for teens nationwide, with isolation and loss of their everyday routines compromising their emotional well-being.

Pandemic restrictions meant months of virtual school, less time with friends, and canceling activities like sports, graduation ceremonies and prom. This contributed to a dramatic increase in anxiety and depression among young

This level of disruption affected some of the most important developmental years for many teens' mental health.

Jose Ramirez is a 16-year-old teen who experienced loneliness, fell into a deep depression and found it too much to handle.

"I hated virtual school, and I felt a lack of motivation. It was hard to keep up with my studies, and it seemed like I was missing out on learning," said Ramirez. "I missed my





WHEREAS, on July 14, 2022 the Board adopted its Resolution 2022-05 which, among other things, declared the Board's intent to (a) adopt the recommended budget for 2023, (b) levy and collect 2023 standby charges upon land in the District's Service Area, (c) fix and charge water tolls for water delivered by the District, (d) fix and charge a Groundwater Charge for groundwater extracted within the District, (e) levy a special assessment on developed and undeveloped land

within the District, and called a public hearing regarding such matters to be conducted on August

11, 2022 at which time any person interested could appear and be heard; and WHEREAS, Resolution 2022-05 was published in the Visalia Times Delta and the Shafter Press and a copy thereof was mailed to each holder of title to land within the District as shown by the District's assessment roll: and WHEREAS, no person has objected with respect to any matter within Resolution 2022-05; and

WHEREAS, it is in the best interest of the District and its landowners that the Board now adopt the budget for 2023, fix and levy standby charges for 2023, fix water tolls for 2023, fix Groundwater Charges for 2023, and fix and levy special assessments on developed and

- determines. The Board hereby adopts the District budget for 2023 as shown on the attached Exhibit A.
- The Board hereby fixes water tolls for 2023 for water delivered by the District at the 3. rates shown on the attached Exhibit B.
- The Board hereby fixes Groundwater Charges for 2023 of up to \$175 per acre foot for groundwater extracted within the District.
- The Board hereby fixes and levies a standby charge of \$91 per acre upon land in the District's Service Area. The standby charges shall be payable in two equal installments, the first of which shall be delinquent if not paid on or before February 1, 2023, and the second of which shall be delinquent if not paid on or before June 1, 2023. A penalty of 10% shall be added to all standby charges that become delinquent and delinquent standby charges

The Board hereby levies a special assessment of \$122 per acre on developed and

- undeveloped land within the District. The special assessments are due September 1, 2022. The special assessment charges shall be payable in two equal installments, the first of which shall be delinquent if not paid on or before February 1, 2023, and the second of which shall be delinquent if not paid on or before June 1, 2023. A penalty of 5% shall be added to all special assessments, or installments thereof, that become delinquent and the District shall immediately begin the tax sale process. Once, the District receives a Certificate of Sale an interest rate of .75% shall be added to the delinquent special assessment for each month, or portion thereof, until the date of redemption or the date upon which the District perfects a Collector's Deed. All property subject to a Certificate of Sale shall be subsequently assessed as though the Certificate of Sale had not been received. The District shall not deliver any water for use on any land as to which any water
- toll, Groundwater Charge, standby charge or special assessment is delinquent. The Secretary shall transmit a certified copy of this resolution to the Clerk of the Board of Supervisors of the County of Kern.
- The Assessor shall give notice of the fixing and levying of the standby charges and the special assessments in the manner required by Water Code section 36826.


## Generals open season with big win

Freshman quarterback Ezekiel added the anchor to the offense, running the ball when needed and passing to his corps of receivers to balance the offense.



## Mental health of teens suffering

friends and going out to have fun. My life felt meaningless.'

Youth rely heavily on social connections for emotional support, and these adjustments have significantly affected their

More than 46% of parents say their teen has shown signs of new or worsening mental health conditions since the pandemic's start in March 2020, according to a study by C.S. Mott Children's Hospital National Poll (Michigan Medicine).

"The pandemic hit teens hard. There was an increase in depressive episodes and serious thoughts of suicide," said Barb Solish, Director of Youth and Young Adult Initiatives at the National Alliance on Mental Illness (NAMI).

Studies shed light on the mental health of U.S. high school students during the pandemic, including a disproportionate level of threats that some students experienced.

More than a third (37%) of high school students reported they experienced poor mental health during the Covid pandemic, and 44% said they persistently felt sad or hopeless during the past year, based on research by the Center for Disease Control and Prevention (CDC).

Mental health professionals stressed that there was an existing problem for youth, but with Covid, the dilemma has been exacerbated.

Dr. Seniora Mathews with Turning Point, a behavioral health advocacy organization, said youth mental health was already high on the radar. "Due to Covid, now one in three youth is

experiencing a mental health disorder," Dr. Mathews said. Some teens developed severe anxiety

symptoms. Rosalinda Chavez, 14, said, "I felt ner-

vous all the time and worried about my future not going to school like I was used to, scared that it would hurt my college goals."

Both Ramirez and Chavez are Latinos, pointing to their Spanish-speaking parents' confusion and lack of understanding.

"I didn't feel comfortable talking to them because I didn't want them to think I was crazy. I had no one to share what I was going through," said Chavez. Maria de Los Angeles Community

Worker with the Kern County of Dignity Health said mental health is stigmatized but more so for Latinos. "There is a lack of education and re-

sources for them, making it difficult for parents to get help for their children," said de Los Angeles.

She said they face disparities in both access to and quality of treatment. 'More than half of Hispanic youth ages

13-18 with serious mental illness may not receive treatment," said de Los Angeles.

Stigma can prevent someone from seek-

"Many teens agonize in silence because they fear judgment," de Los Angeles said.

Parent Sonia Lopez said with the disruption of Covid, her 15-year-old son slept all day and stayed up all night. 'It was hard to motivate him since he did

not have a normal life for a boy his age during the pandemic," Lopez said. "With time, he started to lose weight and any interest outside of video games or social media. His grades dropped dramatically," said Lopez

"Added to this, he lost his grandmother and uncle to Covid. That was particularly hard for him."

But experts are hopeful.

"I remain positive and feel that teens are extremely resilient. They can move past these challenging times with adequate resources and support and there is starting to be more awareness around the issue, which will be good for them," said Dr. Mathews.

Scripture was given not just to inform, but to transform. Starting from that basic principle, we can ask what value there is to being puzzled or stumped from time to time. There ought to be some value, because it keeps happening! Ecclesiastes might have the most

texts like that, but they crop up in other books of the Bible as well.

How might challenging texts serve to transform us? Of course, each verse in



a specific content it communicates, the impact of the verse will largely depend on what it says. But if we can group all the head-scratching texts together, is there some quality they are elicitng in us when we listen to them carefully and receive them by faith?

its context will have

One suggestion is that they're meant to keep us from being simplistic. In other words, puzzling texts help us to cultivate the character quality of discernment. That's a quality the Bible commends (Proverbs 2:3 and Philippians 1:9). That's a sort of X-ray vision, where we know there is something under the surface.

This is a quality we need in order interpret a text in context. But we also need it to distinguish subtle forms of good and evil, or to see through the sheep's clothing that wolves sometimes wear.

So the next time you come across a puzzling passage in your Scripture readpast it. If you slow down, take it in, chew on it a while, maybe the verse itself will shine with meaning — and maybe that difficult text will help you grow in dis-
