City to pay to vaccinate

The city will give up to 500 residents \$50 gift cards to get vaccinated, the City Council determined Tuesday night.

The \$25,000 investment (plus any additional surcharge fees incurred from the gift card company) is intended to increase the city's relatively low vaccination rate.

WASCO

There was a lengthy discussion to consider adopting a resolution authorizing the city manager to use the American Rescue Plan Act of 2021 funds to promote covid-19 vaccination event(s) to incentivize community participation.

Wasco's current vaccination rate is

56.32% with one or more vaccination doses and 50.04% fully vaccinated.

According to a staff report, to increase vaccination rates and drive down case rates, other communities have directly engaged the public by offering incentives (such as gift cards for local businesses) for citizens to receive vaccinations.

Mary Rexius dies at 102

Mary Ellen Rexius, a long time Wasco resident, will be remembered as a loving and giving woman who loved life and gave of herself, her time and passion for her hometown, a true and faithful Tiger.

Rexius passed away last week, at the age of 102. In 1947, Rexius, who was teaching in Tennessee, answered an ad in a Memphis newspaper for a teaching position in Wasco, Ca. Soon after, Rexius boarded a

train for Wasco. "I will always remember that day, stepping off that train in Wasco. It was the hottest day of the month. I had never felt anything like it."

Despite the heat, Rexius stayed in Wasco and soon became a fixture in local schools and in the community.

Rexius taught at several levels, ending her career teaching at Wasco High for over 13 years. Mary Ellen stayed active throughout her life, being a member of several clubs and organizations, including the Wasco Woman's Club and the PEO Chapter.

A couple of years ago, Rexius was honored with a birthday celebration on her 100th birthday, receiving a certificate from the Wasco City Council.

In the last couple of years of her life, Rexius was a resident of Carrington House in Shafter, where she enjoyed some goodnatured ribbing about her affiliation with its rival town.

Council hears opinions on new solid waste service **JAMIE STEWART** The Shafter Press City users of solid waste collection will pay less - or more, if they have alley service now. And the alley service is

SHAFTER going away, as of July 1. The Shafter City Council on the new rates, for service

delivered by American Refuse. Public Works Director Michael James told the attendees at the public hearing Tuesday night that in 2021, the City of Shafter developed a three-cart system that would be utilized by the city for its residents, which is required by the State of California. James said that American Refuse submitted a bid that was then approved by the council.

The rates for residential customers will increase for those who now have alley service. Those customers who have curbside service will see their rate decrease by about two dollars. Customers who have alley service will be paying \$26.55 per month, compared to the \$16.69 they are currently paying – a more than 60% increase.

Four letters of protest were submitted to the council, far from the number needed to block the council from voting on the new rates for all city customers.



Tiny kitten saved

A kitten was rescued from a storm drain thanks to the collaboration of the Public Works Department, Mayor Gilberto Reyna and several good samaritans.

The tiny kitten was trapped in a storm drain located at the corner of Poplar Avenue and Margalo Street.

Wasco resident Iris Paredes Ruiz said she heard crying from inside the sewer.

"My son, Antonio Chayanne, ran to the house to get something to lift the drain cover. However, once we removed the cover, we realized we would need more serious help," Paredes Ruiz said .

"The kitten was scared, and we worried about its safety with the heat. I am an ani-

mal lover, and my heart hurt knowing the kitten was suffering."

Another resident attempted to save the kitten and entered the drain to no avail. Paredes Ruiz then posted a video mes-

sage on social media asking for assistance. Mayor Reyna responded and called Public Works Director Luis Villa, who dispatched the Wastewater Department and Animal Control to the scene. Working together, they successfully

saved the kitten without injury, and it is now safe at the animal shelter.

"I was overjoyed with the news. Hopefully, someone will adopt the sweet kitten soon and provide a loving home," said Pare-



"It is amazing to be able to work alongside my family. We love the Wasco community and enjoy getting to know our clients," said Ramon Sedano Paz.

Both Ramon and Alex were practically raised in the market. Alex was just 3 years old when he would spend his days there, while Ramon started working at 15. They have both played an integral role in the business since then.

city," said Jaretzi Zuno. Community members can host their own neighborhood cleanup effort, and American Refuse will donate garbage bags, rollers and paint to


cover graffiti. 'Code Compliance will also make gloves, vests and trash pickers avail-

Program provides child care and early education

The Community Action Partnership of San Luis Obispo Migrant and Seasonal Head Start Program in Wasco provides high-quality, no-cost child care, early childhood education and preschool services to income-eligible families.

"The mission is to serve migrant children and families who are income-eligible in our service area with a comprehensive program to meet their educational, emotional, social, health, and nutritional needs," said Lupe Sanchez, area manager for south Kern County.

Staff members offer children and families love, acceptance, understanding and the opportunity to learn and experience success.

"Through community participation, staff development, and family involvement, our goal is to assist in providing opportunities now and for future generations," said Family Child Care Coordinator Yolanda

CAPSLO is committed to eliminating the causes of poverty by empowering lowincome individuals and families to achieve self-sufficiency through a wide array of community-based collaborations and pro-"In Wasco, we fully offer a Migrant and

Seasonal Head Start Program that supports these goals through our mission to provide quality comprehensive services to young children and their families," said Chavez. These services include support around

nutrition, health, mental health, education, family, parent involvement and children with disabilities. Migrant agricultural working families are those that travel often through different

counties and states following the crop sea-

sons. They are uprooted from their homes,

often earning minimum wage, and there-

fore are unable to afford safe child care that focuses on meeting educational goals. "We are not only babysitters; we are educators that follow the national Head Start performance standards," said Sanchez.

There is a Migrant and Seasonal Head Start Program center in Wasco that serves

40 preschoolers.

Funded in 2002, the Wasco Las Rosas Migrant and Seasonal Head Start Program center has three teachers per 20 children. Each classroom has to have a qualified teacher with at least an associates degree in early childhood.

"We have six teachers at our Wasco center, all with college degrees. There is also a family service advocate who works with the families, so we have a team. In addition, our staff participates in many hours of training," said Chavez. The second component of the program

contracts with provider homes to provide childcare for infants and toddlers. "We believe they should be in a home

setting environment," said Sanchez. Home providers must meet stringent

state requirements. The providers must also have an educational background focused on early childhood education. They are monitored closely, with regular

visits from CAPSLO Family Childcare coordinators for training and evaluation. Providers participate in monthly work-

shops, seminars and conferences for pro-

fessional development growth. "We also help them with educational materials and equipment to help create quality child care," said Sanchez.

In 2013, the Migrant and Seasonal Head Start Program was acknowledged by the National Head Start Association and received a Quality Initiative recognition that they have maintained up until now.

We are looked at as a leader in child care across the nation," said Chavez. Parents are involved in many aspects of

the program decisions and receive training. "We empower them to be self-sufficient

and are part of our regular meetings. We teach them that they are the first teachers of their children and show them how to advocate for their needs and education," said Sanchez. "If parents want to further their education, we connect them with English or GED classes, and we often time subsidize some of the costs."

The center and home providers are open 11 to 12 hours a day to meet the needs of the farm working migrant community.

Their 2-1-1 program is a resource and referral center available at all times, con-

necting people to more than 1,500 social

safety net services.

"It is always available. We never close that service," said Outreach and Advocacy Coordinator James Burger.

The best thing about the organization is that we serve individuals in their time of need. We are responsive and provide quality services that positively impact the communities we serve," said Ram.

Another initiative that makes a difference in the community is the CAPK Food Bank, distributing 23 million pounds of food a year. "At the height of the pandemic, this increased to 33 million," said Ram.

They host a food distribution event every fourth Thursday of the month from 10 a.m. to noon at West Side Park. They also do a Senior Food Program distribution at Griffith Avenue Church from 10:30 to 11:30 a.m. on the second Tuesday of every

City to pay to vaccinate

A number of these programs have been successful but are not without controversy. In one case, gift cards were offered primarily for local restaurants and grocery businesses. Owners of other (nonfood) businesses were critical because they were excluded from the program, while others questioned the use of public funds to promote a vaccination program which is still controversial for some.

The use of generic cards, such as Visa gift cards, eliminates the possible problem with vendor selection; however, it also allows the incentive to be spent outside of Wasco and not with local vendors.

"These incentive programs work based on data from other towns. This is an excellent opportunity to do something great for our community and keep them healthy," said Mayor Gilberto Reyna.

The program is open to everyone. The question was raised regarding how the city can get the word out to the large Latino Spanish-speaking community, and Mayor Reyna said he has partner-

ships in place to disseminate the information among this demographic.

The resolution to implement a gift card vaccination incentive program was unanimously approved.

"I think it was a very good discussion, and I am excited about it. What better investment than investing in our residents to protect them and us," said Mayor Reyna. Assistant City Manager Maria Lara

announced the recent award of \$10,000 in grants for spade and neuter events and animal shelter needs benefitting Wasco residents. A resolution was unanimously ap-

proved to accept the two \$5,000 awards

each from Pacific Gas and Electric Co.

and from California for All Animals Statewide Animal Shelter Assistance "Money will be used for anything the shelter needs to operate to keep ani-

mals safe and hopefully adopted," said "Good work," said Councilmem-

ber Alex Garcia. "Excellent job," said Mayor Reyna.

A certificate of recognition was presented to Wasco Tigers Taekwondo for their many years of teaching Wasco youth martial arts.

"This helps build their self-esteem, self-defense and confidence and contributes to a more peaceful world," said Mayor Reyna.

"They are to be celebrated because they represent the spirit of Wasco," said Councilmember Garcia.

Sergeant Charles Shinn from the Kern County Sheriff's Department provided the council with a comparison of crime statistics between April and May. His report showed that CFS (calls for service) increased slightly from 842 to 849, total arrests decreased from 60 to 54, citations (traffic/parking) decreased from 42 to 31, patrol checks increased from 83 to 93 and narcotic related cases increased from 10 to 30.

Chief Joe Appleton from the Kern County Fire Department reported on data collected since January 2022 showing that 43% of fires in the county are caused by homelessness or related homelessness.

Council hears opinions on new solid waste service rates

Before the vote, City Councilmember Chad Givens commented that he didn't have a problem with the increase in the collection rates, but he did not agree with the elimination of the alley service now offered. Givens said that he thought that there should still be discussion on retaining the alley service for those who have it now.

Councilmember Gilbert Alvarado said that his residence currently has alley service, but that he sees points on keeping or ending the service. "There is a problem with dumpster diving with the big containers, and if we kept alley service with the three-cart system, there would be 12 different smaller containers in the alley, possibly clogging up the alleyway." The rate increase was approved on a 3-1

vote, with Givens voting "no" because of the alley service elimination. During public comment, former mayor

Garry Nelson spoke about his opposition to the required curbside pickup. "My house was built with the premise of there being alley service for the trash containers. To get my property accessible for curbside pickup, I am facing a cost of \$5,000, and I guarantee you that this will not happen." Nelson said he wouldn't pay that price. Debbie Haley, who also has a residence

that has alley service, concurred with other speakers in saying that a lot of the homes in Shafter were built with alley service in mind. She also mentioned that with curbside service, it will diminish the beauty of



the streets and will not help keep the trash cans from being scavenged.

Colleen Diltz also spoke on the issue. The Shafter resident commented that if she no longer had alley service, that she would not be going into the alley. "I have a trash can in the alley, and I clean and sweep the alley area behind my house, which I will no longer do if there is no alley service.'

Diltz also said that there must have been some misunderstanding on what constitutes a protest. Diltz had submitted a letter of protest on Monday to City Hall with 21 signatures on it, not knowing that this would not constitute a protest. Another city resident, Ron Nunlist, was

also against the elimination of the alley service. Nunlist mentioned that the city will be offering bulky waste pick up once a week, such as mattresses and similar items. "This will not look good with a bunch of bulky waste out in front of our houses. I would rather have those items picked up in the alley, instead of out in the street." Mayor Cathy Prout said that she under-

stands the concerns of a lot of people, but she also commented that

dents earned a gold cord with their cap and gown, symbol-


izing the achievement. After the diplomas were handed out, it was time for the students to congratulate one another, and have one last night as Shafter High seniors.


