City receives \$5M to repair aquatic center

The city was successfully awarded a Clean California grant for almost \$5 million with part of the money earmarked for repairing the Shafter Aquatic Center, Public Works Director Michael James reported to the City Council.

Included in the projects earmarked for this money is the improvements needed to

get the Shafter Aquatic Center open, possibly as early as the beginning of next year.

In other news, the city also received over \$130,000 in monies from KernCOG in their Clean Air project programs. At its recent meeting, the City Coun-

cil approved a resolution that addresses

the public transit needs of the community,

A presentation was made to the council showing how many people utilized the pro-

The report showed that the pandemic drastically impacted the usage of the program. In 2018 and 2019, there was a monthly average of 1,300 riders, with the numbers dropping to a little over 400 riders

especially regarding the city's Dial a Ride

monthly in 2020 and 2021.

Irene Montoya, of GROW Academy, spoke to the council about the need the school had for the Dial a Ride program, with students using the system on a regular basis. She also said at times they were having to wait for 30 minutes or an hour for the student to be picked up, with either drivers at lunch or short staffed that day. She rec-

Shafter man dies in helicopter crash

Steve Wilson, 53, of Shafter, died when his helicopter crashed in orchards in the Coalinga area.

At around 3 a.m. last Tuesday night, the Fresno County Sheriff's Office received a call from American West Aviation, a crop dusting company, about a missing pilot of one of their helicopters. Deputies responded to the area known as Five Points, in the Coalinga area near Harris Ranch to conduct a search. At the same time, the California Highway Patrol and the company sent out airplanes of their own to search. Shortly after, a crop dusting plane re-

ported seeing a matching yellow helicopter down in some trees near S. Sonoma and W. Chandler avenues. Deputies arrived and determined that it

was the helicopter that they were looking for. The pilot, who was the only occupant in the aircraft, was deceased.

An investigation has been started by the Federal Aviation Administration to determine the cause of the accident.

Wilson was spraying a field at night, according to environmental regulations, which requires certain chemicals to be sprayed at night. Local farmer Stan Wilson, who was a student of Wilson's grandfather in Shafter, said that it doesn't make any sense to force this work to be done at Early reports are that Wilson may have

hit a power line. Wilson grew up in Shafter and attended

Shafter schools. Years ago, Wilson learned



to spray crops at his father and grandfather's company, Inland Cropdusters, before becoming a flight instructor and working full time for American West Aviation, where he

had been for the past 20 years. According to friends and family. Wilson loved to fly that big yellow Huey copter and had worked on perfecting the art of cropdusting.

Salas seeks to invest millions in teachers

Assemblymember Rudy Salas recently introduced AB 2489, which will provide \$50 million in grant funds to teachers who work at and live near underserved and understaffed schools.

The grant intends to supplement teachers' salaries who agree to live within the boundaries of the priority school they teach at for five years. Eligible priority schools are K-12 schools with 50 percent or more of their student population eligible for free or reduced-priced meals.

According to a news release by Salas, ensuring schools are adequately staffed with teachers who live in the community establishes a stronger connection between teachers and students, creating a more productive learning experience.

"This bill is important because if we can foster more positive interaction with students and teachers, students' test outcomes increase. By allocating more money for teachers to work and live within the boundaries of an underserved school with high populations of students from low-income families, we know that their test scores will improve. In addition, it is a bonus pay on top of their salaries for those teachers," said Salas.

Salas said with the state's historic

budget surplus of \$46.7 billion, the state needs to invest more in teachers and students.

"Providing incentives to develop neighborhood teachers that live in the same school district as their students will result in better outcomes for our kids," said Salas. "This bill is an innovative approach to recruit and retain our best and brightest educators in struggling school districts."

"I would like teachers to know that we are out here fighting for them, that we are trying to come up with creative ways to increase not only their salaries but also to improve student test scores. It is my goal with the passage of this bill that teachers take full advantage of the program," he shared.

Salas said the bill would particularly benefit cities like Wasco.

"This bill will not only help incentivize teachers, but it is also particularly beneficial when you look at schools like those in Wasco, where 80 percent of students qualify for free and reduced-price meals," said Salas. "It also speaks to the fact that four out of every five districts in California are impacted by teacher shortages, and this bill is a unique, community-based approach to addressing that problem."

Salas encouraged residents to support the bill.

"My hope is that everyone sees the merits in this and wants to support our teachers, schools, and our students. We need letters from community members, school districts, school boards, and teachers to say that this is something that will help student outcomes while also supporting our teachers," said Salas. "I welcome the community to join us in this journey so that we can improve our student test scores and empower our teachers at the same time. I think all of our local schools can greatly benefit from

distance learning option.

According to Principal Brooke Webb, this decision was a good one for the students and staff as well. "There is really no replacement for

learning in the classroom, with your fellow students, being able to interact with them on a daily basis," Webb said.


The school has maintained its improvement that was made in the 2019 school session, which saw them increase English Language scores by 22 points and their Math scores by almost 10 points. Despite these increases, the school is addressing needs in those departments to get them at the state standards, which are a barometer for all schools in California.

Officials said their dedication to individualized learning and differentiated instruction is an important element in ensuring that they are meeting the needs of all of their learners with the ability to serve all of their students with a more personal focus.

They are also focusing on STEM related instruction, with having a small group instructor for their first through fifth graders. This allows them to work closely with the classroom teachers to ensure that the differentiated lesson plans are implemented. They are addressing their specific needs, helping in their academic, social and emotional growth. Another highlight is the Edible School-

yard, which gives the students the knowledge of where their food comes from and how it makes it to the dinner tables. Students are busy helping maintaining

their gardens, hoeing weeds, picking crops and planting seeds, everything that is required to make a productive garden. They also are learning what to do with the food once it is at the table. They are taught basic recipes, as well as having cooking time with their own families. The recipes come from different teachers and staff, and students' families' recipes that they have had for generations.



translate that to the modular and then do the analysis of it."

The community can also attend public meetings and submit comments or feedback on the city's redistricting website. This all needs to happen quickly.

"There is a three-week window until draft maps will be put forth, and so we need input from council members and patrons. We will be asking for final drafts in early April. There is a lot of work that needs to be completed in a short time," said Kent Mar-

tin, of Flo Analytics.

Before adopting a final map, the law requires that the council hold at least four public hearings at which the public is invited to provide input regarding the composition of one or more council districts. At least one public hearing will be held before the council draws a draft map of the proposed council district boundaries. At least two public hearings will be held after the council has outlined a draft map of the proposed boundaries. "The goal is to keep the districts as com-

pact as possible, preserve communities of

mutual interest, and preserve the use of existing administrative and natural boundaries," said Alex Brasch, of Flo Analytics. "Of the five districts, one and three require the most attention to get closer to the ideal population for each district which is 4,559. District one is currently at 6,828, and district three is at 2,727." Based upon public and City Council

input, Flo Analytics will produce no more than five draft maps to be posted on the City of Wasco redistricting webpage by March 21. Those maps will be presented to the City Council for their initial feedback. The public will then give their input at a second public hearing on March 22.

The drafts will then be revised after feedback is considered and will again be shared to the council and at a third public hearing

on March 29. The final map will then be de-

veloped and presented no later than April 5.

"All statutory redistricting criteria will be upheld, including the Voting Rights Act, and be vetted by legal professionals reflecting public sentiment. It will be a compromise," said Brasch.
